This contract will be jointly financed by World Bank and the Government of the Republic of Armenia. Bidding process will be governed by the World Bank's rules and procedures.

The works consist of *placing of leveling blanket, asphalt concrete overlay, Installation of road guardrails, road safety measures, etc.* The rehabilitation should be completed within 7 (seven) months after the contract signing date.

(i) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member management contractor or sub-contractor between 1st January 2010 year and application submission deadline: One contract with minimum value AMD 85 000 000 (or USD 177,000 equivalent) or 2 contracts, each of minimum value AMD42 500 000 (or USD 88,500 equivalent). The similarity shall be based on the physical size, complexity, methods/technology.

- (ii) A minimum experience in the following key activities:
 - EARTH WORKS: min 590 m3 in any year within the last five years
 - PAVEMENT WORKS: min 8,800 m2 in any year within the last five years
 - INSTALLATION OF METAL GUARDRAILS: min 20 l.m. in any year within the last five years
