1. The **Republic of Armenia** has received financing from the Asian Development Bank (ADB) towards the cost of **2860-ARM: Water Supply and Sanitation Sector Project-Additional Financing**. Part of this financing will be used for payments under the contract named above. This contract will be jointly financed by the Armenian Government. Bidding is open to all bidders from eligible source countries of the ADB.
2. The Armenian Water and Sewerage CJSC ("the Employer") invites sealed bids from eligible bidders for the construction and completion of **L2860-ICB-1-03/3, Improvement of the Water Supply Systems in Charentsavan, Abovyan towns and Solak village**

The Works consists of:

Charentsavan town

Distribution network

- Construction of 19.2km length, de315-de40 PE internal waterlines,
- Construction of 0.2km length, de32-de20 PE inlet lines for private houses,
- Installation of 13 water meter chambers.

Abovyan town (Kentron district)

Distribution network

- Construction of 4.0km length, de225-de63 PE internal waterlines,
- Construction of 0.4km length, de32-de20 PE inlet lines for private houses,
- Installation of 30 water meter chambers.

Solak village

External system

- Construction of 1.3km length, de160 PE water main,
- Construction of 40m3 capacity water intake reservoir

Distribution network

- Construction of 6.4km length, de160-de40 PE internal waterlines,
- Construction of 1.6km length, de20-de32 PE inlet lines for private houses,
- Installation of 180 water meter chambers

3. International competitive bidding will be conducted in accordance with ADB's **"Single-Stage: One-Envelope"** bidding procedure and is open to all Bidders from eligible source countries.
4. Only eligible bidders with the following key qualifications should participate in this bidding:

-Minimum average annual construction turnover of US\$ 3,100,000 (three million one hundred thousand US dollars) calculated as total certified payments received for contracts in progress or completed, within the last 3 (three) years.

-Access to or availability of financial resources such as liquid assets, unencumbered real assets, lines of credit and other financial means, other than any contractual advance payments for the amount US\$ 440,000 (four hundred forty thousand US dollars).

-Participation as contractor, management contractor, or subcontractor, in at least 1 (one) contract within the last 3 (three) years, each with a value of at least US\$ 1,320,000 (one million three hundred twenty thousand US dollars) that has been successfully or is substantially completed and that is similar to the proposed works. The similarity shall be construction of 10km of PE Pipelines.

-All pending litigation shall be treated as resolved against the Bidder and so shall in total not represent more than 50 percent of the Bidder's net worth.

The Bidder shall hold a valid and effective license/permit for hydro-technical facilities, issued by the RA Urban Development Ministry. In case of the absence of this license/permit the Bidders shall submit with the bid a signed statement that if the bidder is awarded the Contract he will obtain the required license from the RA Urban Development Ministry.
