

ANNOUNCEMENT

Regarding the Open Procedure

The text of this announcement is approved by the decision of the open procedure committee N 1 on 31 July and is being published according to the Article 24 of the Law “On Procurements” of Republic of Armenia

The code of the open procedure is “ԲԸԱՇՁԲ-ՀՎԿԱԿ-2015-01”

The Customer, **State Non-Commercial Organization “National Center of Disease Control and Prevention”** of the Ministry of Health of RA which is located on Heratsi 12, is announcing the open procedure.

The participant, who has won the open procedure, according to the defined order may sign a contract about “Reinforcement, modernization, renovation and reconstruction works of the total area and the buildings of “National Center of Disease Control and Prevention” SNCO /hereinafter contract/.

According to the terms of Article 6 of the RA Law “On Procurements”, all entities in spite of the state of their, in spite of being a foreign entity, organization, having no citizenship are permitted to participate in the process of the open procedure.

The persons who were announced bankrupt, have overdue debts of social and tax payments of RA, has been convicted of economic activity or public services during previous three years at the moment of filling the application, except for those cases when the conviction has been defined by the law or is cancelled, according to the list of participants with no right of participation in the procurement process.

According to the invitation, the participant professional activities’ obligations of the contract include, professional experience, technical resources, financial resources, labour resources.

The participant is selected from the number of participants submitted bids assessed as satisfactory, who has proposed the minimal price, with whom the contract is signed.

For receiving an open procedure invitation it is necessary to apply to the Customer till 10:00 *am* of the 40th day from the day of publication of this announcement. In particular, for receiving invitation in hard copy it is necessary to present to the Customer an application in written form. The Customer provides the invitation in hard copy free of charge.

In case of 50-times exceedence of the procurement base unit, bids can be presented in Russian and/ or English, in addition to Armenian.

For receiving the invitation in Russian or English it is necessary to present to the Customer an application in written form. The Customer provides the invitation in Russian or English free of charge within 10 working days starting from the day of receiving such requirement.

In case of electronic form invitation requirement the Customer provides the electronic invitation form during the working day following the date of receiving the request.

Failure to receive an invitation does not restrict the right of participant to take part in this procedure, according to the order stipulated in this invitation

The bids of the open procedure must be submitted in hard copy to the following address: II floor, Heratsi st. 12, Yerevan, RA, Financial Department, on the 40-th day starting from the day of publication of the announcement, at 10:00 a.m.. The Bids must be drawn up in Armenian.

Bid opening will be held in hard copy on the II floor, at Heratsi st.12, Yerevan, RA, on the 40-th day (**October 9th**) starting from the day of publication of the announcement, at 10:00 a.m..

The complaints regarding the open procedure are presented to Procurement Assistance Centre in Komitas st. 54/b address. Appeal is carried out in accordance with section 12 of part 1 of this invitation.

Participants have to present to the Customer all documentation required by the tender documents of the open procedure in order to evaluate the relevance of conditions if required.
