

## ***Announcement for Open Tender***

The text for this announcement is approved by evaluating committee per protocol N 2 dated November 2, 2015 and is published according to article 24 of RA Law on "Procurement",

**Open Tender Code is "NCET-OTSP-15/1"**

The Customer - "National Center for Educational Technologies" State Non Commercial Organization, which is located at Yerevan, Vratsyan 73 address, announces an open tender.

The winner- participant of the open tender in a defined order will be offered to sign a service providing contract (henceforth - Contract) on "Armenian educational network service for 2016".

According to the provisions of article 6 of RA Law on "Procurement" everyone can apply to this tender regardless of being a foreigner, a foreign company or a non-citizen.

Those participants, who have been avowed insolvent in legal form, have any overdue debts for the Republic of Armenia's tax and obligatory social insurance payments, whose representative of executive body at the moment of submitting the bid within the preceding three years was condemned for crime against economic activity or state service, with the exception of cases, when the condemnation is redeemed in legal form, who are on the "do not have right to take part in the procurement process" list, don't have the right to take part in the open tender.

To carry out the obligations defined by the contract, the Participant shall meet the following requirements of the invitation: professional compatibility with the activity defined by the contract, professional experience, technical means, financial assets, human resources.

The winner will become the participant who has submitted the lowest price proposal among the participants whose bids have been evaluated as satisfactory and will be offered to sign a contract.

It is necessary to contact the Customer to obtain the open tender invitation till the 40<sup>th</sup> day, 11:00 starting from the day of announcement publication. To obtain a hard copy of the open tender invitation, a written application shall be submitted. The Customer provides a printed copy of the invitation free of charge.

In case of exceeding the base unit of Procurement fifty-fold, applications can also be submitted in Russian and/or English languages, apart from Armenian. It is necessary to submit a written request to the Customer to receive the Russian or English version of the invitation. The invitation in Russian or English is being provided if the copy of the bank receipt about the payment of 400000 (four hundred thousand) AMD is presented.

The payment should be made to ARMECONOMBANK, Spandaryan branch, account: 163048288407.

If there is a claim to obtain the electronic version of the open tender invitation, the Customer provides the invitation in an electronic way within a working day after receiving the request for it.

Failure to receive an invitation, envisioned by this call for proposals, does not limit the Participant's right to take part in this procedure

The tender bids envelopes are to be submitted to the address: Yerevan, Vratsyan 73 in printed form until the 40<sup>th</sup> day, by 11:00 starting from the day of announcement publication and they should be presented in Armenian.

The opening of the tender bids envelopes will take at Yerevan, Vratsyan 73 on the 40<sup>th</sup> day, at 11:00.

The complaints on this tender shall be submitted to the Purchase support center: Komitas 54b, Yerevan, RA. The appeal process is being carried out according to the order defined in chapter 12 of invitation part 1.

To evaluate the compatibility of the Participants' qualification data with the tender invitation provisions, the Participants need to submit to the Customer all the documents required by the tender invitation.
