The Republic of Armenia has received additional financing from the World Bank toward the cost of the **Lifeline Roads Network Improvement Project**, and intends to apply part of the proceeds toward payments under the contract for **Civil works for rehabilitation and maintenance of road section H6-Nor Gehi-Argel-Arzakan-Hrazdan section km10+000-km25+232** (Kotayk region).

2. The **Transport Projects Implementation Unit State Institution of Ministry of Transport and Communication of the Republic of Armenia** now invites sealed bids from eligible bidders for **Contract CW-NCB-LRNIP-AF-2016/8 Civil works for rehabilitation and maintenance of road section H6-Nor Gehi-Argel-Arzakan-Hrazdan section km10+000-km25+232**. The works consist of removal of old sub base and construction of new sub base, crushed stone base, asphalt layer, asphalt concrete overlay, drainage, road safety measures, etc. The rehabilitation should be completed within 15 (fifteen) months. In order to qualify for the Contract a Bidder must have experience in similar rehabilitation works and adequate resources, as detailed in the Bidding Document.

3. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Small Works under National Competitive Bidding (NCB) procedure under IBRD Loans and IDA Credits & Grants by World Bank Borrowers published on January 2011 January 31, 2013 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

4.
