Contract Title: Technical Re-equipment of Communities comprising of eight lots

1. The Republic of Armenia has received financing from the USAID toward the cost of the Local Government Reform Activity, and intends to apply part of the proceeds toward payments under the contracts for Technical re-equipment of communities comprising of eight lots. Bidding process will be governed by the World Bank's rules and procedures.

2. The Armenian Territorial Development Fund now invites sealed bids from eligible bidders for:

Lot 1: Procurement of 2 Graders

Lot 2: Procurement of 4 Multifunctional Excavators

Lot 3: Procurement of 3 Dump Trucks (A)

Lot 4: Procurement of 2 Dump Trucks (B)

Lot 5: Procurement of 1 Multifunctional Municipal and Snow Removal Equipment

Lot 6: Procurement of 1 Garbage Truck (A)

Lot 7: Procurement of 4 Garbage Trucks (B)

Lot 8: Procurement of 2 Passenger Vans

The delivery period is 60 days.

3. Bidders may bid for one or several contracts (lots), as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the Letter of Bid.

4. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's [Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers](#) ("Procurement Guidelines" January 2011, revised in July 2014), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

5. Interested eligible bidders may obtain further information from address below and inspect the bidding documents during office hours 10:00 am to 1:00 pm and 2:00 pm to 5:00 pm.

6. A complete set of Bidding Documents in English may be obtained by interested bidders free of charge on the submission of a written Application to the address below. The bidding documents will be available also on the <http://gnumner.am/am/category/129/1.html> website free of charge. However the ATDF will not be responsible for incorrect or incomplete downloading documents by the potential bidders, or missed amendments to those (if any).

7. Bids must be delivered to the address below on or before *26 October, 2016, 12:00 AM*. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on *26 October, 2016, 12:00 AM*.

8. All bids must be accompanied by a *Bid-Securing Declaration*. The bid for each lot should be accompanied with separate Bid-Securing Declaration.
