

## **ANNOUNCEMENT**

### **On Open procedure**

**The text of this announcement is approved by the 30 December 2016 N2 Decree of Evaluation Committee and is being published according to Article 24 of the "Law On Procurements" of the Republic of Armenia**

**The code of the Open procedure: RA-MNP-OP-ASHDZB-17/01**

Customer, the Ministry of Nature Protection of RA, located in Government Building 3, Republic Square, Yerevan, RA is announcing the open procedure.

The participant declared as the winner in the open procedure according to the defined order will be suggested to sign procurement contract on "Cleaning activities of covered with water forest stands of Lake Sevan" (hereinafter referred to as Contract).

According to the terms of Article 6 of the RA Law "On Procurements", all persons or entities, irrespective of being a foreigner, a foreign entity or a stateless person, may submit bids for the open procedure.

The individuals or organizations have no right to participate in the open procedure process who have been declared judicially bankrupt, who have overdue tax or compulsory social security debts to the RA tax office, whose representative of the organization at the time of presenting the application, during the previous three years has been convicted for making crime against economic activity or the official service, except for the case of the conviction being legally removed or cancelled, who are included in the list of participants who have no right to participate in purchase procedure.

The participant must have corresponding professional activities, professional experience, technical resources, financial resources, working resources required by invitation made for the responsibilities determined by the contract.

The winner of open procedure is the participant who has submitted the lowest bid proposal according to the applications of the participants assessed as satisfactory with whom the contract is concluded.

To receive an invitation for the open procedures it is necessary to apply to the client till the deadline of submitting the applications which is clearly defined in the websites [www.gnumner.am](http://www.gnumner.am) and [www.armeps.am](http://www.armeps.am). Moreover in order to get documentary form of the invitation the customer must get an application in written form. The customer provides the invitation in documentary form free of charge.

In case of exceeding the fifty times of the base unit of purchasing, applications can be submitted in Russian and (or) in English besides Armenian.

To receive an invitation in English or Russian written application is submitted to the customer and the copy of the bank statement confirming that the amount required for the English or Russian invitation is paid.

The amount paid for the English or Russian invitation is 250000 AMD. The payment should be made to the following bank account: Unibank A/N 24124005544200. In this case the Customer provides the invitation within 10 working days after receiving such request. Invitation provided in Russian or in English has the same legal force as that in Armenian. If the the Russian or English invitation differs from that of the Armenian one then the existing difference is interrupted in favor of the participant.

In the case of requesting an electronic form of invitation, the invitation is provided in electronic form the next working day of the date of receiving the request.

Not receiving an invitation according to the norms doesn't limit the participant's right for participation.

Open procedure applications must be submitted in electronic form in the webpage [www.armeps.am](http://www.armeps.am) until the 41-th day at 11:00 am counting from the publishing day of this Announcement and they must be composed in Armenian.

The procurement procedure will be implemented in electronic form through [www.armeps.am](http://www.armeps.am) webpage. The opening of the applications will be held according to the RA law "on Procurements" through [www.armeps.am](http://www.armeps.am) website (hereinafter referred to as Webpage).

All the complaints on open procedure are submitted to "Purchase Support Center" SNCO located in Yerevan, str. Komitas 54/b, according to the provisions of the 1st part of the 12-th section of this invitation.

For evaluating the conformity of qualification data of participants with the conditions specified by invitation of open procedure, the participants must present to the customer documents provided by invitation procedure.
