1. The Republic of Armenia has applied for financing from Asian Development Bank (ADB) towards the cost of P49244-ARM: Rehabilitation/reconstruction the existing M6 Vanadzor–Alaverdi–Georgian border interstate road. Part of this financing will be used for payments under the contracts named hereunder. This Invitation for Bids follows the Advance Contracting Notice for the Project that appeared in the “ADB Business Opportunities” issued on (October 25, 2016). Bidding is open to bidders, who can prove their eligibility and qualification as mentioned hereunder and in the Bidding Documents, from eligible source countries of the ADB:
