

**ANNOUNCEMENT
A PRICE QUOTATION ENQUIRY**

The text of this announcement is approved by the Decision N 1 of the Tender Committee dated June 19, 2017 and is being published according to Article 27 of the Law of the Republic of Armenia "On Procurements".

The code of the price quotation enquiry procedure: ZAMC-PQESP-09/17

The Customer, the “Zvartnots AMC” CJSC, located at Zvartnots-2, Airport, Yerevan, RA, announces pricing inquiry carried out in 1 phase through Armeps (www.armeps.am) electronic procurement system.

The selected participant of the pricing inquiry will be invited under relevant procedure to sign a “Car maintenance services” contract /hereinafter referred to as Contract).

According to Article 7 of the RA Law on Procurements, any person, regardless of his/her being a foreign physical person, organization or stateless person, shall be equally entitled to participate in the pricing inquiry.

The qualification criteria for the persons not entitled to participate in the pricing inquiry, as well as for the participants, and the documents submitted to evaluate such criteria are specified by the present procedure invitation.

The selected participant is chosen from among the participants who submitted bids assessed as meeting the invitation requirements by the principle of preference to the participant submitting the minimum price bid.

To get a hardcopy pricing inquiry invitation, please apply to the Customer by 11:00 AM of the 6th day following the publication date of the present announcement. Moreover, to get a hardcopy invitation, a written application must be submitted to the Customer. The Customer ensures free provision of hardcopy invitation on the first business day following the receipt of the request.

In case of getting a request for an electronic invitation, the Customer ensures provision of a free electronic invitation within the working day following the day of getting the application.

Failure to receive an invitation does not restrict a participant's right to take part in the present procedure.

Pricing inquiry bids must be submitted electronically through Armeps (www.armeps.am) e-procurement system by 11:00 AM of the 7th day following the publication date of the present announcement. Apart from Armenian, bids can be also submitted in English or Russian.

The bids will be opened electronically through Armeps e-procurement system at 11:00 AM of the 7th day following the publication date of the present announcement.

Complaints regarding this procedure must be submitted to the Procurement Appeals Board at the address below: 1, Melik-Adamyan St., Yerevan. The appeal procedure must be carried out as prescribed by this pricing inquiry invitation. To submit a complaint, a fee of 30.000 (thirty thousand) AMD must be transferred to the treasury bank account «**900008000482**» opened in the name of the Republic of Armenia Ministry of Finance.
