(Ministry of Defence of Iraq / General Directorate of Contracts and Sales) are pleased to invite the qualified and experienced bidders to submit their bids to supply **(MILITARY SUPLLIES)**, and note the following:

1. The qualified bidders who want to obtain additional information shall call General Directorate of Contracts and sales at (9 00 – 1500 ) VIA EMAIL: [Moddg.contracts@ucidn.iraqi-mod.org](mailto:Moddg.contracts@ucidn.iraqi-mod.org) or mobile 07902783136 as shown in instructions to bidders.
2. The requisite qualification requirements ( **Supplying MILITARY SUPLLIES** ) .
3. Interested bidders can buy bid documents , after submitting written request addressed to ministry of defence / general directorate of contracts and sales , after paying amount (100.000) Iraqi dinars
4. The bids are delivered to the following address (Baghdad- karadat Merriam near al-Jamahiriya Bridge / entrance of green zone) at the specified date up to **(1400 of Wednesday 11<sup>th</sup> Oct. , 2017 )** late bids will be rejected, and they will be opened by the attendance of the bidders or their representatives at the ABOVE MENTIONED ADDRESS and at time **(1400 of Wednesday 11<sup>th</sup> Oct., 2017 )**.
5. Advertisement's duration shall be on **Tuesday 19<sup>th</sup> Sep. up to 1400 of Wednesday. 11<sup>th</sup> Oct. 2017.**
6. The total estimated cost: **(\$ 999.882) nine hundred ninety nine thousands and eight hundred eighty two USD.**
7. **Wanted country of origin: UK**
8. The supplying period : **90 days**
9. The good performance bond that equals to (5%) of the total contract's amount shall be submitted after awarding prior to signing contract .it must be unconditional and payable on request issued by governmental bank or accredited bank to the central Iraqi bank as for (Iraqi companies and foreign companies that have representation in Iraq) and a bank accredited by trade bank of Iraq (TBI ) as for foreign companies that don't have representation in Iraq.
10. ~~To submit a non- objection letter to participate in tenders issued by General Commission of Taxes as for local companies and (foreign that have representation in Iraq) addressed to ministry of defence with taxes identity and number.~~
11. Iraqi & representation's bureau of foreign companies in Iraq must submit a letter of discharge issued by Retirement and Social Security Office.
12. To submit stamp's fee **(0.003)** of the contract's amount at the same contract's currency as per act. # 71 of 2012 and **(0.001 )** of contract's amount as per judicial fee on condition not to exceed (10.000) Iraqi dinars according to (act # 11 of 2015).
13. Iraqi and foreign companies must submit their financial statements of the last two years at least. Iraqi and foreign companies which have a bureau of representation have to submit a letter issued by Accountants Corporation certifying the legal situation of the accountant who submits the final accounts within the documents of them.
14. Written prices shall be based when differ of digits and unit price shall be based if error is

found in items' prices (Arabic will be based if there is contradiction with English)

15. Evaluation shall be conducted using:

A – No deviation in supply items

b- Availability of after sale service and spare parts in country of buyer for the equipments offered in the bid.

c- The quick supplying

b- Compatibility to required specifications.

D- competitive quotations.

16. To submit a list of achieved similar works certified by contracting entities.

17. To write prices in applications of the fourth & sixth section in handwriting.

18. The first party has the right to deduct any debts from the second party 's payment (if there is any) according to Iraqi governmental debts act # (56) of 1977.

19. Contract shall be subject to all Iraqi valid acts even the Income Taxes Law # 113 of 1982 and its instructions and amendments.

20. The winner shall bear the fees of the advertisement of the last time.

21. No scrape or amendment in the tender's documents shall be accepted

22. If many bidders take part in one tender, their contract's partnership must be submitted.

23. If the tender is cancelled by the buyer, the amount of buying the documents of the tender shall be returned to bidders without any compensation.

24. Authorized manager of many companies shall be allowed to submit only one offer.

25. The date of holding a meeting to answer companies' inquiries at 1300 of Tuesday 3<sup>rd</sup> Oct. 2017

26. Buyer is not obliged to accept the lowest offers.

27. If the closing date coincides to be an official holiday, the next day shall be the closing.

28. The tender's box shall be opened during the working hours of the whole advertisement duration (900 up to 1400).

29. If bidder will not commit to all requirements of bid standard documents of tender, their offers shall be excluded.

30. bidders shall review the standard bid documents of ( 97) pages in Arabic with translation according to ministry of planning letter # 27131 dated on 22/ 12 / 2016 and fill the required ones ,the attached disc is for clarification .
