1. The **Republic of Armenia** has received financing from the Asian Development Bank (ADB) towards the cost of **2860-ARM : Water Supply and Sanitation Sector Project-Additional Financing**. Part of this financing will be used for payments under the contract named above. This contract will be jointly financed by the Armenian Government. Bidding is open to all bidders from eligible source countries of the ADB.

2. The Armenian Water and Sewerage CJSC (“the Employer”) invites sealed bids from eligible bidders for the construction and completion of **L2860-ICB-1-06/2, Improvement of water supply systems in Gavar town and Karmirgyugh village**

The Works consists of:

Gavar town (Hatsarat district)

- Rehabilitation of existing 500m³ capacity DRR, reconstruction of technological units and pipe sections
- Construction of 33.3 km length, de50-de225 PE internal waterlines
- Construction of 8.6 km length, de20-de32 PE inlet lines for private houses with installation of 1056 water meter chambers

Karmirgyugh village

- Construction of 26.8 km length, de40-de250 PE internal waterlines
- Construction of 7.9 km length, de20-de32 PE inlet lines for private houses with installation of 950 water meter chambers

International competitive bidding will be conducted in accordance with ADB’s **“Single-Stage: One-Envelope”** bidding procedure and is open to all Bidders from eligible source countries.

3. Only eligible bidders with the following key qualifications should participate in this bidding:

-Minimum average annual construction turnover of US\$ 3.360.000 (three million three hundred sixty thousand US dollars) calculated as total certified payments received for contracts in progress or completed, within the last 3 (three) years.

- Access to or availability of financial resources such as liquid assets, unencumbered real assets, lines of credit and other financial means, other than any contractual advance payments for the amount of US\$ 900.000 (nine hundred thousand US dollars).

-Participation as contractor, management contractor, or subcontractor, in at least 1 (one) contract within the last 3 (three) years, each with a value of at least US\$ 1.792.000 (one million seven hundred ninety-two thousand US dollars) that has been successfully or is substantially completed and that is similar to the proposed works. The similarity shall be construction of 13km of PE Pipelines.

-All pending litigation shall be treated as resolved against the Bidder and so shall in total not represent more than 50 percent of the Bidder's net worth.

The Bidder shall hold a valid and effective license/permit for hydro-technical facilities, issued by the RA Urban Development Ministry. In case of the absence of this license/permit the Bidders shall submit with the bid a signed statement that if the bidder is awarded the Contract he will obtain the required license from the RA Urban Development Ministry.
