

**PREQUALIFICATION ANNOUNCEMENT**  
**FOR NEGOTIATION PROCEDURE BY INITIAL PUBLICATION OF THE PROCUREMENT ANNOUNCEMENT**  
**DUE TO EMERGENCY OR OTHER UNFORESEEABLE CIRCUMSTANCE BEARING THE CODE TRBNA-NPASP-14/1**

The text of this announcement is approved by the Decision N1 of 22 of April 2014 of the Evaluation Commission of the negotiation procedure by initial publication of the procurement announcement due to emergency or other unforeseeable circumstance, and is published according to the Article 21 of the RA Law "On Procurement"

1. The Client, "Television and radio broadcasting network of Armenia" CJSC, located at the address 95str., Hovsepyan, Nork, 0047, Yerevan, Armenia, announces a negotiation procedure (hereinafter Procedure) by initial publication of procurement announcement.

The subject of procurement is purchasing of 10GB bandwidth fiber-optic system data transmission services.

Procurement procedure is organized on the base of 7<sup>th</sup> clause of 14<sup>th</sup> article "On procurement" of the RA law.

The winner of the current procedure will be offered to conclude a procurement contract on the "For purchasing 10GB bandwidth fiber-optic system data transmission services" (hereinafter Contract).

2. Applications for participation in the announced Procedure may be submitted by anyone, irrespective of being non-resident physical persons, organizations or having no citizenship.

3. The following entities cannot participate in the announced procedure:

- a) entities that have been recognized bankrupt by the court;
- b) having overdue debts on RA tax and social security payments;
- c) whose representative of the executive body was convicted for an offense against economic activities or state service during the preceding three years counted from the moment of the submission of the bid, with the exception of the cases where the conviction is removed or cancelled according to the order established by law;
- d) included in the list of bidders not entitled to participate in procurement procedure.

4. For the purpose of the usage of this procedure, prequalification applications must be submitted within 10 calendar days after the date of publication of the announcement.

5. For the purpose of the evaluation of the right of participation, the participant must submit an announcement. Besides the mentioned announcement, other documents can not be required from the participant. The recommended form of the announcement and the requirements set forth for it are presented in the Annex N 2.

For the purpose of participation in the Prequalification procedure, the participant must comply with the activities stipulated in the contract, as required by this announcement for the fulfillment of contractual obligations. For the purpose of evaluation of the mentioned qualification criterion, the participant must submit an announcement, the recommended form of which and the requirements set forth for it are presented in the Annex N 3.

6. The participants can participate in the Prequalification procedure as joint activity (by consortium). In such case:

- a) a joint activity agreement is also included in the prequalification application;
- b) in the evaluation of the prequalification application it is also taken into account, that the qualification of each member of the joint activity agreement must comply with the qualification requirements established by this announcement to the extent of this member's liability undertaken by the contract mentioned in the sub-point;
- c) the participants bear joint and equal liability.

7. The Client must respond, within three calendar days, to the participant's request for explanations about the prequalification, if such request has been received no later than five calendar days prior to the deadline for submission of prequalification bids. The Client meanwhile publishes in the Bulletin information about the request and provided explanations without disclosing the data of the inquirer. In case of providing information to a participant, the Client must ensure the accessibility of that information to all other potential bidders.

8. The participants included in the list of prequalified participants, gain the right for participation in procurement process.

9. The prequalification bid includes a written application approved by the participant for participation in the prequalification procedure, the recommended form of which and the requirements set forth for it are presented in the Annex N 1; a written announcement approved by the participant on compliance of its data with the requirements for the established right to participation and qualification criteria, attaching the information requested by this announcement (Annexes N 2 and N 3); a joint activity agreement, if the participants participate in the prequalification procedure as consortium; the electronic mail address of the participant.

10. Prequalification bids are to be submitted in an official form to the address: 95str., Hovsepyan, Nork, 0047, Yerevan, Armenia, to the procurement department M. Nikolyan, till 15:00a.m. (Yerevan time), within 10 calendar days

counted from the day of publication of this announcement, and besides Armenian, they must be also submitted in English or Russian.

The documents included in the bid are put in an envelope, which is glued by its submitter. The documents included in the envelope must be constituted of both their originals and of two copies. The envelope and documents included in it must be signed by the participant submitting them or by the person authorized by the latter. If the bid is submitted by an agent, a document confirming their relevant authority must be presented. On the envelope the following information in the language of the bid must be mentioned:

- a) the name of the client and the place of submitting the bid;
- b) prequalification procedure code;
- c) “Do not open until the opening session”
- d) the name of the participant, its address and telephone number.

The prequalification bid may be submitted in an electronic way with version scanned from the original to the attention of the Secretary of the Committee for assessment with electronic letter.

Opening of bids will take place at the address: **95str., Hovsepian, Nork, 0047, Yerevan, Armenia**, in the Conference hall at **15:00** a.m. (Yerevan time) **10** calendar day estimated from the date of publication of this announcement.

Any complaints concerning this procedure can be presented to the Procurement Support Center, according to the order established by the **6th** Chapter of the Law.

Submitted documents are received and registered in a separate registry book by Mrs. M. Nikolyan.
